## 2006 AMENDMENT TO MASTER DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF GARLAND MEADOWS

THIS 2006 AMENDMENT ("Amendment"), supplementing and amending the Master Declaration Of Covenants, Conditions and Restrictions for Garland Meadows subdivision, Hailey, Idaho, recorded on March 12, 1996, as Instrument No. 387848 and on July 17, 1996 as Instrument no. 392352, records of Blaine County, Idaho, (all singularly and collectively the "Declaration") is made pursuant to Article XI, ¶ 11.2.B and Article IX, ¶ 9.04 of the Declaration on the date first below signed.

1. Amendment. Article IX of the Declaration is hereby amended as follows:

In the case of costs associated with maintaining and repairing the decks or balconies but not the front entry porches, as well as costs arising out of their initial construction, the Special Assessment shall be assessed to the Owner of the deck and balcony for which the costs are incurred.

- 2. Conflict. In the event of any conflict between the Declaration and this Amendment, this Amendment shall prevail.
- 3. Authority. This Amendment was authorized by a majority vote of at least a seventy-five per cent majority (21 in favor, 1 opposed) of the Lot Owners of the Garland Meadows Homeowners association, Inc., at the Annual Meeting of Owners on December 12, 2006.
