FIRST AMEMDMENT TO THE RESTATED AND AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR VAL D' SOL SUBDIVISION NOS. 1, 2 AND 3

THIS FIRST AMENDMENT ("First Amendment") to the Restated and Amended Declaration of Covenants, Conditions and Restrictions for Val d'Sol Subdivision Nos. 1, 2 and 3 ("Declaration") is made on the 6th day of June, 2006, by the Val d'Sol Homeowners Association ("Association") and has been approved by a vote or written consent of more than sixty-six and two-thirds percent (66 2/3%) of the lot owners of Val d'Sol Subdivision Nos. 1, 2 and 3, Blaine County, Idaho ("Lot Owners").

RECITALS

- A. The Declaration was recorded on December 17, 2003, as Instrument No. 496720, records of Blaine County, Idaho.
- B. The Association and Lot Owners desire to amend the Declaration to specifically provide for the assignment and delegation of the maintenance cost of particular improvements to specific Lot Owners as provided hereinafter.
- C. This Amendment to the Declaration is made pursuant to Paragraph 10, <u>Amendment</u>, of the Declaration.

WHEREFORE, a new subparagraph 7.d) <u>Particular Improvements and Circumstances</u>, is hereby added to the Declaration to read as follows:

"7. Assessments.

d) Particular Improvements and Circumstances. The Association may assign and delegate the maintenance and repair costs of a specific component of Common Area, landscaping, or exterior walls and roofs of residences to a Lot Owner. Such component may be an approved upgrade or modification requested by and
